2 *An Act to amend and reenact § 24.2-105.1 of the Code of Virginia, relating to elections administration;*

7 **Be it enacted by the General Assembly of Virginia:**8 **1. That § 24.2-105.1 of the Code of Virginia is amended and reenacted as follows:**9 **§ 24.2-105.1. Election and voter participation information on the Internet.**

10 ~~Beginning with the general election in November 1998, the State Board~~ *The Department shall*  
11 *provide information for voters on its website, including (i) the role of and contact information for the*  
12 *State Board, the Department of Elections, local electoral boards, and general registrars; (ii) how and*  
13 *where to register to vote; (iii) how and where to vote, including information about absentee voting,*  
14 *polling hours, Virginia's voter identification requirements and acceptable forms of identification, the*  
15 *casting of ballots, and a means for voters to find their polling place; and (iv) any laws, regulations,*  
16 *policies, or forms pertaining to any of the information in clauses (i), (ii), and (iii). The website shall*  
17 *also allow a voter to review his current voter registration information and voting history that is kept in*  
18 *the statewide voter registration database.*

19 ~~The Department shall implement a system by which it shall furnish lists of candidates for all~~  
20 ~~elections in the Commonwealth, and information on proposed constitutional amendments and statewide~~  
21 ~~referenda prepared pursuant to §§ 30-19.9 and 30-19.10, electronically through the Internet. The Board~~  
22 ~~Department may list other referenda issues on the Internet. The lists and information shall be made~~  
23 ~~available on the Internet as far in advance of the election as practicable and remain available on the~~  
24 ~~Internet at least until the day after the election.~~

25 ~~The State Board~~ *Department shall provide election results and statistical information on its website.*  
26 *The information shall include voter turnout information which shall be calculated as the percentage of*  
27 *active voters who voted excluding voters assigned to inactive status pursuant to Chapter 4 (§ 24.2-400 et*  
28 *seq.). The information shall also include the total number of registered voters and the number assigned*  
29 *to inactive status.*

30 *At a minimum, the Department shall provide a version of its website in which all parts required by*  
31 *this section are translated into any language that is spoken by a language minority group covered under*  
32 *subsection A of § 24.2-128. Any page on the Department's website that is linked to a translated page*  
33 *shall also be translated. The Department shall review all translated portions of its website for accuracy*  
34 *and make appropriate updates prior to the start of early voting for every primary and general election*  
35 *held in Virginia.*
