2 An Act directing the Joint Legislative Audit and Review Commission to study the social, physical,
 3 emotional, and economic effects of gun violence on communities across the Commonwealth. Report.

6 WHEREAS, according to the Centers for Disease Control and Prevention and the National Center for
7 Health Statistics, 4,482 Virginians died by firearm between 2018 and 2021, and the firearm homicide
8 rate in Virginia increased by 21 percent in that time; and

9 WHEREAS, in addition to fatal shootings, gun violence includes other firearm-involved crimes and
10 incidents in which a victim may suffer from non-fatal gunshot wounds, may be shot at but not wounded,
11 or may be threatened with a brandished firearm that is not fired; and

WHEREAS, not only does gun violence result in physical harm, it can also lead to long-term adverse
effects on the overall health and well-being of individuals, as well as lasting social and economic
impacts on communities; and

WHEREAS, in order to reduce gun violence and its enduring consequences, it is important to understand the extent of such social, physical, emotional, and economic effects on communities in the Commonwealth; now, therefore, be it

18 RESOLVED by the House of Delegates, the Senate concurring, That the Joint Legislative Audit and
 19 Review Commission be directed to study the social, physical, emotional, and economic effects of gun
 20 violence on communities across the Commonwealth.

In conducting its study, the Joint Legislative Audit and Review Commission shall examine the impact of gun violence on (i) the overall physical health of individuals living in affected communities, (ii) the mental and emotional health of individuals living in affected communities, and (iii) the social and economic health of communities impacted by gun violence and shall consider and propose policy recommendations to address gun violence and its effects.

All agencies of the Commonwealth shall provide assistance to the Joint Legislative Audit and ReviewCommission for this study, upon request.

The Joint Legislative Audit and Review Commission shall complete its meetings for the first year by 28 29 November 30, 2024, and for the second year by November 30, 2025, and the chairman shall submit to the Division of Legislative Automated Systems an executive summary of its findings and 30 31 recommendations no later than the first day of the next Regular Session of the General Assembly for 32 each year. Each executive summary shall state whether the Joint Legislative Audit and Review Commission intends to submit to the General Assembly and the Governor a report of its findings and 33 34 recommendations for publication as a House or Senate document. The executive summaries and reports 35 shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General Assembly's 36 37 website.
