That § 24.2-673.1 of the Code of Virginia is amended and reenacted as follows: 11 § 24.2-673.1. (Expires July 1, 2031) Ranked choice voting. 12 A. For purposes of this section: 13 "Ranked choice voting" means a method of casting and tabulating votes in which (i) voters rank 14 15 candidates in order of preference, (ii) tabulation proceeds in rounds such that in each of round either a 16 candidate or candidates are elected or the last-place candidate is defeated, (iii) votes for voters' next-ranked candidates are transferred from elected or defeated candidates, and (iv) tabulation ends when 17 the number of candidates elected equals the number of offices to be filled. "Ranked choice voting" is 18 19 known as "instant runoff voting" when electing a single office and "single transferable vote" when electing multiple offices. 20 21 "Ranking" means the ordinal number assigned on a ballot by a voter to a candidate to express the 22 voter's preference for that candidate. Ranking number one The first ranking is the highest ranking, the 23 second ranking number two is the next-highest ranking, and so on, consecutively, up to the number of 24 candidates indicated on the ballot. 25 B. Elections of members of a county board of supervisors or a city council for any local or 26 constitutional office may be conducted by ranked choice voting pursuant to this section. The decision to 27 conduct an election by ranked choice voting shall be made, in consultation with the local electoral board 28 and general registrar, by a majority vote of the board of supervisors or city council that the office being 29 elected serves local governing body. The decision to use ranked choice voting in an election for any 30 constitutional office that is shared by two or more units of government shall require a majority vote of 31 the governing body of each county or city that shares such office. C. In any election conducted by ranked choice voting, as soon as the polls are closed on the day of 32 33 the election, the officers of election for each precinct shall proceed to ascertain the vote and prepare 34 returns for the first rankings made for such election in the same manner as provided for votes in other 35 elections under this article. The results for elections conducted by ranked choice voting shall be 36 reported along with other results reported on election night, except that such results shall clearly be 37 identified as preliminary and based on the first rankings in a ranked choice voting election. 38 D. In any election conducted by ranked choice voting for a local or constitutional office that is not 39 shared by more than one county or city, final tabulation of votes shall be conducted at the meeting of 40 the electoral board held pursuant to § 24.2-671. 41 E. In any election conducted by ranked choice voting for a local or constitutional office that is 42 shared by more than one county or city, the Department shall select a suitable facility in which to securely store the election materials and conduct the final tabulation of votes in the ranked choice 43 voting election after the local electoral boards have met pursuant to § 24.2-671. The Department will 44 contract with a private courier service (courier) to provide secure retrieval of the election materials 45 46 from the appropriate localities and deliver them to the tabulation facility. The Department will provide 47 transmittal forms to document the chain of custody from the locality to the courier's personnel to the Department personnel at the tabulation facility and the materials required to accomplish such 48 49 transmittal, including tamper evident packaging and seals. 50 The final tabulation of votes shall be conducted under the supervision of the Department by the 51 electoral boards of the relevant localities and their officers of election and shall be open to the public. 52 The Department shall provide public notice of the final tabulation. 53 F. If, in the process of tabulating final results for an election conducted by ranked choice voting, any 54 machine readable ballot is damaged or defective so that it cannot properly be counted by the electronic 55 voting systems, a true duplicate copy shall be made of the damaged ballot by a team of election officials representing both parties. The duplicate ballot shall be substituted for the damaged ballot. Every 56 duplicate ballot shall be clearly labeled as such and shall bear an identifier that shall be recorded on 57 58 the damaged ballot.

The Department shall make public the total number and percentage of votes each candidate 60 received in each round of the official tabulation, including votes for withdrawn candidates and 61 ballot-level ranking data on an election-by-election basis in a machine-readable, open format that can 62 be retrieved, downloaded, indexed, sorted, and searched by commonly used Internet search applications 63 and commonly used open format software, in a manner identifiable by precinct to the extent such 64 identification is feasible and can be provided consistent with the need to maintain voter privacy.

H. The State Board shall provide standards for vote tabulating software for use with existing voting systems in elections conducted by ranked choice voting. Any person, firm, or corporation manufacturing, owning, or offering for sale any vote tabulation software designed to be used with existing voting systems may apply to the State Board, in the manner prescribed by the Board, to have examined a production version of such software. A governing body that makes the decision to conduct elections by ranked choice voting shall provide for the use of vote tabulating software approved by the Board in any such elections.

I. The State Board may *shall* promulgate regulations for the proper and efficient administration of
 elections determined by ranked choice voting, including (i) procedures for tabulating votes in rounds, (ii)
 procedures for determining winners in elections for offices to which only one candidate is being elected
 and to which more than one candidate is being elected, and (iii) standards for ballots pursuant to
 § 24.2-613, notwithstanding the provisions of subsection E of that section.

77 D. J. The State Board may administer or prescribe standards for a voter outreach and public 78 information program for use by any locality conducting ranked choice voting pursuant to this section.

79 K. Any risk-limiting audit of elections conducted by ranked choice voting pursuant to § 24.2-671.2
80 shall be limited to an audit of first rankings reported by voting systems.
81 2. That the Department of Elections (the Department) be directed to review the testing and

81 approval framework for voting equipment in the Commonwealth. In conducting its review, the 82 83 Department shall (i) review the types of voting equipment covered by state law; (ii) review emerging forms of voting equipment, such as electronic pollbooks, risk-limiting audit tools, and 84 tabulation software; (iii) review the roles and responsibilities of state and local election officials in 85 the testing and approval of voting equipment; (iv) review any existing testing and approval 86 87 frameworks for emerging forms of voting equipment; (v) develop recommendations for objective 88 methods of evaluating the performance of emerging forms of voting equipment to determine if 89 they are appropriately executing the elections tasks for which they are intended; and (vi) make 90 other recommendations as necessary and review other issues as warranted. The Department shall 91 submit to the Division of Legislative Automated Systems an executive summary and report of its 92 review no later than the first day of the 2025 Regular Session of the General Assembly. The executive summary and report shall be submitted for publication as a report document as 93 provided in the procedures of the Division of Legislative Automated Systems for the processing of 94 95 legislative documents and reports and shall be posted on the General Assembly's website.
