3. Committee: Passed both Houses.

4. Title: Chief Resilience Officer of the Commonwealth; Interagency Resilience Management Team.

5. Summary: Adds additional duties to the position of Chief Resilience Officer (CRO) and requires the CRO to convene an Interagency Resilience Management Team to support the coordination of planning and implementation of resilience efforts. The bill eliminates the position of Special Assistant to the Governor for Coastal Adaptation and Protection. In addition, the bill requires the Director of the Department of Conservation and Recreation to convene an Advisory Review Committee to assist in the distribution of loans and grants from the Virginia Community Flood Preparedness Fund and the Resilient Virginia Revolving Fund. Further, the bill adds the Secretary of Natural and Historic Resources and the CRO to the list of those with whom the Virginia Resources Authority is required to consult in directing the distribution of loans or grants from the Resilient Virginia Revolving Fund. The bill requires, for the two Funds, the Department to (i) make available for public inspection at the office of the Department and on a publicly accessible website records of each application for grants and loans and the actions taken thereon and (ii) provide an opportunity for a 30-day public comment period prior to each new grant or loan offering to solicit feedback on proposed revisions to the Funds' manuals. The Virginia Flood Resilience Advisory Committee replaces the Virginia Coastal Resilience Technical Advisory Committee effective February 1, 2025.

7. Fiscal Impact Estimates: Final.

8. Fiscal Implications: This bill expands the duties of the position of Chief Resilience Officer (CRO) and creates an Interagency Resilience Management Team. Currently, the CRO position is unfilled, and funding was not provided to the Secretary of Natural and Historic Resources for this position.

This bill also eliminates the position of the Special Assistant to the Governor for Coastal Adaptation and Protection. This position was funded during the 2018-2020 biennium at \$140,000 from the general fund in each year in the Office of the Governor. It is anticipated that this funding may be used to support the Chief Resilience Officer.

The fifth enactment of this bill requires the CRO to submit a report on the funding and staffing no later than December 31, 2025.

The bill requires the CRO to convene an Interagency Resilience Management Team to support the coordination of planning and implementation of resilience efforts and requires the Director of the Department of Conservation and Recreation (DCR) to convene an Advisory Review Committee to assist in the distribution of loans and grants from the Virginia Community Flood Preparedness Fund and the Resilient Virginia Revolving Fund. The bill also requires DCR to records available and provide a 30-day comment period for these two Funds. It is anticipated that any impact on DCR and the affected agencies required to serve on the working group and the advisory committees will be minimal and can be absorbed within current resources.

Conference amendments to HB30/SB30 include \$500,000 from the general fund in each year to establish an Office of Commonwealth Resilience within the Office of the Governor.
