- **8. Fiscal Implications:** This FIS has been updated to reflect revised information from VDACS. Budget amendments will be necessary to move appropriation currently supporting the preservation of farm and forest lands from VDACS to DOF. In each year, the Introduced budget contains \$437,500 from the general fund deposit to the Virginia Farmland Preservation Fund, \$151,570 from the general fund to support a position administering the program, and a nongeneral fund appropriation of \$60,000 to spend funds generated from the sale of specialty license plates.
