**4. Title:** Department of Agriculture and Consumer Services; Department of Forestry;  
Office of Farmland.

**5. Summary:** Transfers from the Virginia Department of Agriculture and Consumer Services (VDACS) to the Department of Forestry (DOF) the Office of Farmland Preservation and its powers and duties and reporting requirements, the Virginia Farm Link Program, the Century Farm Program, and the Virginia Farmland Preservation Fund. The bill renames the Office as the Office of Working Lands Preservation. The bill also requires the Department of Environmental Quality to take effects on farm and forest land under consideration when preparing environmental reports and to report annually to the Department of Forestry on nonpoint source nutrient credits. The bill makes technical amendments to effectuate the transfer.

- 8. Fiscal Implications:** Budget amendments will be necessary to move appropriation currently supporting the preservation of farm and forest lands from VDACS to DOF. In each year, the Introduced budget contains \$437,500 from the general fund deposit to the Virginia Farmland Preservation Fund, \$151,570 from the general fund to support a position administering the program, and a nongeneral fund appropriation of \$60,000 to spend funds generated from the sale of specialty license plates. The Department of Environmental Quality anticipates being able to absorb any fiscal impact from the passage of this legislation within current resources.

The conference report transfers \$589,070 each year from the general fund, \$60,000 each year from nongeneral funds, and one position from VDACS to DOF to implement the provisions of this bill.
