#### **Estimate of Local Fiscal Impact**

2024 General Assembly Session | 1/19/24

In accordance with the provisions of 30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of legislation impacting local governments.

SB 480: Public utilities; municipal utilities, disconnection of service, consumer protections. (Patron: Sen Lashrecse D. Aird)

Bill Summary: Suspends electric, gas, water, and wastewater utilities subject to the regulation of the State Corporation Commission from disconnecting service to a residential customer for nonpayment of bills or fees during a state of emergency declared by the Governor and provides that such suspension lasts for 30 days after such declaration of the state of emergency. The bill suspends such electric and gas utilities from disconnecting service to a residential customer for nonpayment of bills or fees when the forecasted temperature low is at or below 32 degrees Fahrenheit and suspends electric utilities from disconnecting any such customer from service when the forecasted temperature high is at or above 95 degrees Fahrenheit within the 24 hours following the scheduled disconnection. The bill further suspends electric, gas, water, and wastewater utilities from disconnecting residential customers from service on Fridays, weekends, state holidays, and the day immediately preceding a state holiday. The bill also creates similar requirements for utilities owned or operated by a locality of the Commonwealth and provides customers a civil cause of action if the municipally owned or municipally operated utility fails to comply with the requirements of the bill.

Number of Localities Responding: 6 Cities, 5 Counties, 3 Towns, 0 Other

Localities estimated an increase in expenditures ranging from \$0 to \$910,000 over the biennium.

Localities estimated a decrease in revenues ranging from \$0 to \$200,000 over the biennium.

Most localities did not indicate an increase in expenditures. Those that did identified increased recurring personnel costs to track notices and collect data. One locality noted additional recurring costs related to sending notices and potential liability as well as one-time expenditures for software upgrades.

Most localities indicated no loss in utility revenue. Those that do anticipate losses noted that they would come from increased unrecoverable utility bills and write offs.
