That § 22.1-253.13:1 of the Code of Virginia is amended and reenacted and that the Code of Virginia is amended by adding sections numbered 22.1-199.1 and 22.1-276.01 as follows: § 22.1-199.1. Program for improving educational opportunities. In recognition of the importance of setting long-term educational improvement goals and the significance of early childhood education, educational technology, and parental and community involvement, the General Assembly establishes the following objectives: 1. By the year 2000, the General Assembly shall seek to ensure that licensed instructional personnel shall be assigned by each school board in a manner that produces divisionwide ratios of students in average daily membership to full-time equivalent teaching positions in grades kindergarten through three, excluding special education teachers, principals, assistant principals, counselors, and librarians, that are not greater than the following: a statewide ratio of twenty to one and a targeted ratio of sixteen to one in schools with high concentrations of at-risk students. 2. Effective July 1, 1994, the availability of voluntary programs for at-risk four-year-old children shall be increased as provided in the appropriation act. 3. Effective July 1, 1994, access to educational technology shall be expanded as set forth in the appropriation act. "Educational technology" means distance learning, integrated learning systems (ILS), multimedia library packages, laptop computer loan programs, vocational technology/diversified technology laboratories (DTL), or other electronic techniques designed to enhance education and teacher training in the use of instructional technology. 4. Effective July 1, 1994, with such funds as are appropriated for this purpose, incentives for parental and community involvement shall be strengthened as set forth in § 22.1-250.1. § 22.1-253.13:1. Standard 1. Basic skills, selected programs, and instructional personnel

The Board of Education shall establish educational objectives to implement the development of the skills that are necessary for success in school and for preparation for life in the years beyond. The current educational objectives, known as the Standards of Learning, shall not be construed to be regulations as defined in § 9-6.14:4; however, the Board of Education may, from time to time, revise these educational objectives. In order to provide appropriate opportunity for input from the general public, teachers, and local school boards, the Board of Education shall conduct public hearings prior to establishing new educational objectives. Thirty days prior to conducting such hearings, the Board shall give written notice by mail of the date, time, and place of the hearings to all local school boards and any other persons requesting to be notified of the hearings and publish notice of its intention to revise these educational objectives in the Virginia Register of Regulations. Interested parties shall be given reasonable opportunity to be heard and present information prior to final adoption of any revisions of these educational standards. However, no revisions shall be implemented prior to July 1, 1994. These objectives shall include, but not be limited to, basic skills of communication, computation and critical reasoning including problem solving and decision making, and the development of personal qualities such as self-esteem, sociability, self-management, integrity, and honesty. School boards shall implement these objectives or objectives specifically designed for their school divisions that are equivalent to or

60 exceed the Board's requirements. Students shall be expected to achieve the educational objectives utilized by the school division at appropriate age or grade levels. With such funds as are available for 61 this purpose, the Board of Education may prescribe assessment methods to determine the level of 62 63 achievement of these objectives by all students.

64 C. Local school boards shall develop and implement a program of instruction for grades K through 65 12 which emphasizes reading, writing, speaking, mathematical concepts and computations, and scientific 66 concepts and processes; essential skills and concepts of citizenship, including knowledge of history, economics, government, foreign languages, international cultures, health, environmental issues and 67 geography necessary for responsible participation in American society and in the international 68 community; fine arts and practical arts; knowledge and skills needed to qualify for further education and 69 employment or, in the case of some handicapped children, to qualify for appropriate training; and 70 development of the ability to apply such skills and knowledge in preparation for eventual employment 71 72 and lifelong learning.

Local school boards shall also develop and implement programs of prevention, intervention, or 73 remediation for students who are educationally at risk including, but not limited to, those whose scores 74 75 are in the bottom national quartile on Virginia State Assessment Program Tests, or who do not pass the 76 literacy test prescribed by the Board of Education. Division superintendents may require such students to take special programs of prevention, intervention, or remediation which may include attendance in public 77 78 summer school sessions. Students required to attend such summer school sessions shall not be charged 79 tuition. Based on the number of students attending and the Commonwealth's share of the per pupil costs, 80 additional state funds shall be provided for summer remediation programs as set forth in the 81 appropriation act. 82

D. Local school boards shall also implement the following:

83 1. Programs in grades K through 3 which emphasize developmentally appropriate learning to enhance 84 success.

85 2. Programs based on prevention, intervention, or retrieval designed to increase the number of 86 students who earn a high school diploma or general education development (GED) certificate. As 87 provided in the appropriation act, state funding, in addition to basic aid, shall be allocated to support 88 programs grounded in sound educational policy to reduce the number of students who drop out of 89 school.

90 3. Career education programs infused into the K through 12 curricula that promote knowledge of 91 careers and all types of employment opportunities including but not limited to, apprenticeships, the 92 military, and career education schools, and emphasize the advantages of completing school with 93 marketable skills. School boards may include career exploration opportunities in the middle school 94 grades.

95 4. Competency-based vocational education programs, which integrate academic outcomes, career 96 guidance and job-seeking skills for all secondary students including those identified as handicapped that 97 reflect employment opportunities, labor market needs, applied basic skills, job-seeking skills, and career 98 guidance. Career guidance shall include employment counseling designed to furnish information on 99 available employment opportunities to all students, including those identified as handicapped, and 100 placement services for students exiting school. Each school board shall develop and implement a plan to 101 ensure compliance with the provisions of this subsection.

102 5. Academic and vocational preparation for students who plan to continue their education beyond 103 secondary school or who plan to enter employment.

104 6. Early identification of handicapped students and enrollment of such students in appropriate 105 instructional programs consistent with state and federal law.

7. Early identification of gifted students and enrollment of such students in appropriately 106 differentiated instructional programs. 107

108 8. Educational alternatives for students whose needs are not met in programs prescribed elsewhere in 109 these standards. Such students shall be counted in average daily membership (ADM) in accordance with 110 the regulations of the Board of Education.

9. Adult education programs for individuals functioning below the high school completion level. 111 Such programs may be conducted by the school board as the primary agency or through a collaborative 112 arrangement between the school board and other agencies. 113

114 10. A plan to make achievements for students who are educationally at risk a divisionwide priority which shall include procedures for measuring the progress of such students. 115

E. Each local school board shall employ with state and local basic, special education, gifted, and 116 vocational education funds a minimum number of licensed, full-time equivalent instructional personnel 117 118 for each 1,000 students in average daily membership (ADM) as set forth in the appropriation act. Calculations of kindergarten positions shall be based on full-day kindergarten programs. Beginning with 119 120 the March 31 report of average daily membership, those school divisions offering half-day kindergarten shall adjust their average daily membership for kindergarten to reflect eighty-five percent of the total 121

122 kindergarten average daily memberships.

123 F. In addition to the positions supported by basic aid and in support of regular school year remedial 124 programs, state funding, pursuant to the appropriation act, shall be provided to fund certain full-time 125 equivalent instructional positions for each 1,000 students in grades K through 12 estimated to score in 126 the bottom national quartile on Virginia State Assessment Program Tests and those who fail the literacy 127 tests prescribed by the Board. State funding for remedial programs provided pursuant to this subsection 128 and the appropriation act may be used to support programs for educationally at-risk students as 129 identified by the local school boards.

130 The Board of Education shall establish criteria for identification of educationally at-risk students, 131 which shall not be construed to be regulations as defined in § 9-6.14:4; however, the Board of Education 132 may, from time to time, revise these identification criteria. In order to provide appropriate opportunity 133 for input from the general public, teachers, and local school boards, the Board of Education shall 134 conduct public hearings prior to establishing or revising such identification criteria. Thirty days prior to 135 conducting such hearings, the Board shall give written notice by mail of the date, time, and place of the 136 hearings to all local school boards and any other persons requesting to be notified of the hearings and 137 publish notice of its intention to establish or revise such identification criteria in the Virginia Register of 138 Regulations. Interested parties shall be given reasonable opportunity to be heard and present information 139 prior to final adoption of any such identification criteria or revisions thereto.

140 G. Licensed instructional personnel shall be assigned by each school board in a manner that produces 141 divisionwide ratios of students in average daily membership to full-time equivalent teaching positions, 142 excluding special education teachers, principals, assistant principals, counselors, and librarians, that are 143 not greater than the following ratios: (i) twenty-five to one in kindergarten with no class being larger 144 than thirty students; if the average daily membership in any kindergarten class exceeds twenty-five 145 pupils, a full-time teacher's aide shall be assigned to the class; (ii) twenty-four to one in grade one with 146 no class being larger than thirty students; (iii) twenty-five to one in grades two and three with no class 147 being larger than thirty students; (iv) twenty-five to one in grades four through six with no class being 148 larger than thirty-five students; and (v) twenty-four to one in English classes in grades six through 149 twelve.

150 In addition, instructional personnel shall be assigned by each school board in a manner that produces 151 schoolwide ratios of students in average daily memberships to full-time equivalent teaching positions of 152 twenty-five to one in middle schools and high schools.

153 H. Effective July 1, 1995, and as set forth in the appropriation act, licensed instructional personnel 154 shall be assigned by each school board in a manner that produces divisionwide ratios of students in 155 average daily membership to full-time equivalent teaching positions in grades kindergarten through 156 three, excluding special education teachers, principals, assistant principals, counselors, and librarians, that are not greater than the following: a statewide ratio of twenty-two to one and a targeted ratio of 157 158 eighteen to one in schools with high concentrations of at-risk students. The ratios established in (iv) and 159 (v) of subsection G above shall be maintained. 160

§ 22.1-276.01. Parental responsibility and involvement requirements.

161 A. Within three weeks of the beginning of the school year, school boards shall send, simultaneously 162 with any other materials customarily distributed at that time, to the parents, guardians, or other persons 163 having control or charge of each enrolled student, a notice of the requirements of this section.

164 B. Within one calendar month of the opening of school, every parent, guardian, or other person 165 having control or charge of an enrolled student shall:

166 1. Meet with the child's homeroom teacher or the school's principal, assistant principal, or other 167 designated licensed school personnel to review the school board's standards of student conduct and 168 discuss the parent's and the teacher or other school official's expectations of the child. The teacher or other school official shall explain the school board's disciplinary policies and inform the parent of the 169 170 parent's responsibility to assist the school in disciplining the student and maintaining order; and

171 2. Sign a statement acknowledging the requirements of the school board's standards of student 172 conduct and recognizing his responsibility to assist the school in disciplining the student and 173 maintaining order.

174 C. A school board shall notify the parents, guardians or other persons having control or charge of 175 any student who violates a school board policy and is assigned a penalty of in-school or out-of-school 176 suspension of the date and particulars of the violation, of the requirement that the parent accompany 177 the student to meet with school officials, and of the obligation of the parent to take actions to improve 178 the student's behavior.

No suspended student shall be admitted to the regular school program until such student and his 179 180 parent have met with school officials to discuss improvement of the student's behavior.

181 D. Upon the failure of any parent to accompany a suspended student to meet with school officials, or 182 upon the student receiving a second suspension or being expelled, the attendance officer shall make

complaint in the name of the Commonwealth before the juvenile and domestic relations district court or 183

any successor in interest of that court. Any child suspended twice or more times during a single school year shall be deemed to be a "child in need of supervision" who is habitually and without justification absent from school pursuant to Chapter 11 of Title 16.1, and the child and his parent shall be subject 184 185

to the provisions of § 16.1-278.5. E. A school board shall provide opportunities for parental and community involvement in every 188 189 school in the school division.
