That §§ 3.1-249.27. 3.1-249.51, 3.1-249.53 and 9-6.14:14.1 of the Code of Virginia are amended 12 and reenacted as follows: 13 14 § 3.1-249.27. Definitions. 15 As used in this chapter, unless the context requires a different meaning: "Active ingredient" means, in the case of a pesticide other than a plant regulator, defoliant, desiccant, 16 or anti-desiccant, an ingredient which will prevent, destroy, repel or mitigate insects, fungi, rodents, 17 weeds, or other pests. 18 "Agricultural commodity" means any plant or part thereof, or animal, or animal product, produced by 19 20 a person, including farmers, ranchers, vineyardists, plant propagators, Christmas tree growers, 21 aquaculturists, floriculturists, orchardists, foresters, nurserymen, wood treaters not for hire, or other comparable persons, primarily for sale, consumption, propagation, or other use by man or animals. 22 23 "Board" means the Pesticide Control Board." "Bond" means a written instrument issued or executed by a bonding, surety, or insurance company 24 25 licensed to do business in the Commonwealth, or otherwise approved by the Board, guaranteeing the fulfillment of the agreement between the licensee and the customer. 26 27 "Certificate" means the document issued to a certified applicator or registered technician who has 28 completed all the requirements of Article 3 (§ 3.1-249.51 et seq.) of this chapter. 29 "Certification" or "certified" means the recognition granted by the Pesticide Control Board to an 30 applicator upon satisfactory completion of Board approved requirements. "Certified applicator" means a person who (i) has satisfactorily completed the Board requirements for 31 32 certification as a commercial applicator, registered technician, or private applicator, and (ii) has been 33 issued a valid certificate. 34 "Commercial applicator" means any person who has completed the requirements for certification as 35 determined by the Board, including appropriate training and time in service, to use or supervise the use 36 of any pesticide for any purpose or on any property other than as provided in the definition of private applicator. 37 38 "Commissioner" means the Commissioner of Agriculture and Consumer Services. 39 "Committee" or "advisory committee" means any advisory committee appointed pursuant to § 3.1-249.29. 40 41 "Defoliant" means any substance or mixture of substances intended for causing the leaves or foliage 42 to drop from a plant, with or without causing abscission. "Department" means the Department of Agriculture and Consumer Services. 43 44 "Desiccant" means any substance or mixture of substances intended for artificially accelerating the 45 drying of plant tissue. "Device" means any instrument or contrivance intended for trapping, destroying, repelling, or 46 mitigating insects or rodents or destroying, repelling, or mitigating fungi, bacteria, or weeds, or such 47 **48** other pests as may be designated by the Commissioner, but not including treated wood products or 49 simple, mechanical devices such as rattraps, or equipment used for the application of pesticide when 50 sold separately therefrom. 51 "Fumigant" means any substance which by itself or in combination with any other substance emits or 52 liberates a gas or gases, fumes or vapors, which gas or gases, fumes or vapors, when liberated and used, 53 will destroy vermin, rodents, insects, and other pests. "Fungicide" means any substance or mixture of substances intended for preventing, destroying, 54 55 repelling, or mitigating any fungi or plant disease. "Herbicide" means any substance or mixture of substances intended for preventing, destroying, 56 repelling, or mitigating any weed. 57 "Ingredient statement" or "guaranteed analysis statement" means a statement of the name and 58 percentage of each active ingredient, together with the total percentage of the inert ingredients, in the 59

60 pesticide; and, in addition, in case the pesticide contains arsenic in any form, a statement of the 61 percentages of total and water soluble arsenic.

62 "Insect" means any of the numerous small invertebrate animals generally having a body more or less 63 obviously segmented, for the most part belonging to the class Insecta, comprising six-legged, usually 64 winged forms, as, for example, beetles, bugs, bees, flies, and to other allied classes of arthropods whose 65 members are wingless and usually have more than six legs, as, for example, spiders, mites, ticks, 66 centipedes, and wood lice.

"Insecticide" means any substance or mixture of substances intended for preventing, destroying, 67 68 repelling or mitigating any insects which may be present in any environment whatsoever.

69 "Label" means the written, printed or graphic matter on, or attached to, the pesticide or device, or the immediate container thereof, and the outside container or wrapper of the retail package, if any, of the 70 71 pesticide or device.

72 "Labeling" means all labels and other written, printed, or graphic matter (i) upon the pesticide or device or any of its containers or wrappers, (ii) accompanying the pesticide or device at any time, or 73 74 (iii) to which reference is made on the label or in literature accompanying the pesticide or device, 75 except when accurate, nonmisleading reference is made to current official publications of the agricultural 76 experiment station, the Virginia Polytechnic Institute and State University, the Department of Agriculture and Consumer Services, the State Board of Health, or similar federal institutions or other official 77 78 agencies of the Commonwealth or other states when such agencies are authorized by law to conduct 79 research in the field of pesticides.

80 "Licensed" or "licensee" means those businesses which, upon meeting the requirements established by 81 the Pesticide Control Board, are issued a license to engage in the sale, storage, distribution, recommend the use, or application of pesticides in Virginia in exchange for compensation. 82

"Misbranded" shall apply to any pesticide or device:

84 1. If its labeling bears any statement, design, or graphic representation relative thereto or to its ingredients which is false or misleading in any particular; 85 86

2. If it is an imitation of or is offered for sale under the name of another pesticide;

3. If its labeling bears any reference to registration under this chapter;

88 4. If the labeling accompanying it does not contain directions for use which are necessary and, if 89 complied with, adequate for the protection of the public;

90 5. If the label does not contain a warning or caution statement which may be necessary and, if 91 complied with, adequate to prevent injury to living man and other vertebrate animals, vegetation, and 92 useful invertebrate animals;

93 6. If the label does not bear an ingredient statement or guaranteed analysis statement on that part of 94 the immediate container and on the outside container or wrapper, if there be one, through which the 95 ingredient statement or guaranteed analysis statement on the immediate container cannot be clearly read, 96 of the retail package which is presented or displayed under customary conditions of purchase; provided, 97 that the commissioner may permit the ingredient statement to appear prominently on some other part of the container, if the size or form of the container makes it impracticable to place it on the part of the 98 99 retail package which is presented or displayed under customary conditions of purchase;

7. If any words, statement, or other information required by or under the authority of this chapter to 100 appear on the labeling is not prominently placed thereon with such conspicuousness (as compared with 101 102 other words, statements, designs, or graphic matter in the labeling) and in such terms as to render it 103 likely to be read and understood by the ordinary individual under customary conditions of purchase and 104 use;

8. If in the case of an insecticide, fungicide, or herbicide, when used as directed or in accordance 105 106 with commonly recognized safe practice, it shall be injurious to living man or other vertebrate animals or vegetation, to which it is applied, or to the person applying such pesticide, excepting pests and 107 108 weeds: or

109 9. If in the case of a plant regulator, defoliant, or desiccant when used as directed it shall be 110 injurious to living man or other vertebrate animals, or vegetation to which it is applied, or to the person applying such pesticide; provided, that physical or physiological effects on plants or parts thereof shall 111 not be deemed to be injury, when this is the purpose for which the plant regulator, defoliant, or 112 desiccant was applied, in accordance with the label claims and recommendations. 113

114 "Pest" means any organism that exists under circumstances that make it deleterious to man or the 115 environment if it is: any vertebrate animal other than man; or any invertebrate animal, such as any 116 insect, other arthropod, nematode, or mollusk such as a slug or snail, but excluding any internal parasite of living man or other living animals; or any plant growing where not wanted, such as any moss, alga, 117 liverwort, fungus, or other plant of any higher order, and any plant part such as a root; or any bacterium, virus, or other microorganisms, except for those on or in living man or other living animals 118 119 120 and those on or in processed food or processed animal feed, beverages, drugs, as defined in provisions of the Federal Food, Drug, and Cosmetic Act at 21 USC § 321(g)(i), and cosmetics, as defined in 121

122 provisions of the Federal Food, Drug, and Cosmetic Act at 21 USC § 321(i). Any organism classified as 123 endangered, threatened, or otherwise protected under federal or state laws shall not be deemed a pest for 124 the purposes of this chapter.

125 Pesticide" means: (i) any substance or mixture of substances intended for preventing, destroying, 126 repelling, or mitigating any insects, rodents, fungi, bacteria, weeds, or other forms of plant or animal life 127 or viruses or bacterium, except viruses on or in living man or other animals, which the Commissioner 128 shall declare to be a pest, (ii) any substance or mixture of substances intended for use as a plant 129 regulator, defoliant, or desiccant, and (iii) any substance which is intended to become an active 130 ingredient in any substance defined in clause (i) and (ii).

131 "Pesticide business" means any person engaged in the business of: distributing, applying or recommending the use of a product; or storing, selling, or offering for sale pesticides directly to the 132 133 user. The term "pesticide business" does not include (i) wood treaters not for hire; (ii) seed treaters not 134 for hire; (iii) operations which produce agricultural products unless the owners or operators of such operations described in clauses (i), (ii), and (iii) are engaged in the business of selling or offering for 135 136 sale pesticides, or distributing pesticides to persons outside of that agricultural producing operation in 137 connection with commercial transactions; or (iv) businesses exempted by regulations adopted by the 138 Board.

139 "Plant regulator" means any substance or mixture of substances, intended through physiological 140 action, for accelerating or retarding the rate of growth or rate of maturation, or for otherwise altering the 141 behavior of ornamental or crop plants or the produce thereof, but shall not include substances to the 142 extent that they are intended as plant nutrients, trace elements, nutritional chemicals, plant inoculants, 143 and soil amendments.

144 "Private applicator" means an applicator who uses or supervises the use of any pesticide which is 145 classified for restricted use for purposes of producing any agricultural commodity on property owned or 146 rented by him or his employer or, if applied without compensation other than trading of personal services between producers of agricultural commodities, on the property of another person. 147

148 "Registered technician" means an individual who has satisfactorily completed Board requirements for 149 certification to apply general use pesticides, and to apply restricted use pesticides while under the direct 150 supervision of a certified commercial applicator. Registered technicians render services similar to those 151 of a certified commercial applicator, but have not completed all the requirements to be eligible for 152 certification as a commercial applicator. 153

"Registrant" means the person registering any pesticide pursuant to the provisions of this chapter.

154 "Repellent" means a substance, not a fumigant, under whatever name known, which may be toxic to 155 insects and related pests, but is generally employed because of its capacity for preventing the entrance or 156 attack of pests.

157 "Restricted use pesticide" or "pesticide classified for restricted use" means any pesticide classified as restricted by the Administrator of the United States Environmental Protection Agency. 158

159 "Rodenticide" means any substance or mixture of substances intended for preventing, destroying, 160 repelling or mitigating rodents or any other vertebrate animal which the Commissioner shall declare to 161 be a pest.

162 'Serious violation" means a violation of this chapter or regulation promulgated by the Board where 163 there is a substantial probability that death or serious physical harm to persons, serious harm to property, 164 or serious harm to the environment could have resulted from the violation unless the person or licensee 165 did not or could not with the exercise of reasonable diligence know of the violation.

166 "State special use" or "pesticide classified for restricted use in the Commonwealth" means any 167 pesticide that, after special review, is judged by the Board to be so hazardous or injurious to persons, 168 pollinating insects, animals, crops, wildlife, lands, or the environment, other than the pests it is intended 169 to prevent, destroy, control, or mitigate, that additional restrictions on its sale, purpose, use, or 170 possession are required.

171 "Under the direct supervision of" means the act or process whereby the application of a pesticide is 172 made by a competent person acting under the instructions and control of a certified applicator who is 173 responsible for the actions of that person.

174 "Unreasonable adverse effects on the environment" means any unreasonable risk to man or the 175 environment, taking into account the economic, social, and environmental costs and benefits of the use 176 of any pesticide.

177 "Use" means the employment of a pesticide for the purposes of (i) preventing, destroying, repelling, 178 or mitigating any pest, or (ii) regulating plant growth, causing defoliation or desiccation of plants. The 179 term "use" shall include application or mixing, and shall include handling or transfer of a pesticide after the manufacturer's original seal is broken. The term "use" shall also include any act with respect to a 180 181 particular pesticide which is consistent with the label directions for that particular pesticide.

182 § 3.1-249.51. Restricted use pesticides prohibited; exceptions. HB1445

183 A. No person shall use any pesticide classified for restricted use unless that person (i) has first 184 complied with the certification requirements of the Board; (ii) is engaged in the training necessary for 185 certification as a commercial applicator or registered technician, while under the direct on-site 186 supervision of a certified applicator; or (iii) is engaged in the production of an agricultural commodity 187 while under the direct supervision of a private applicator on property owned or leased by that private 188 applicator.

189 B. The Board may specify by regulation the amount of training, which may include a period of 190 service, required to qualify a person for each classification or subclassification of certification as a 191 commercial applicator or registered technician. 192

§ 3.1-249.53. Agencies or persons exempt or partially exempt.

193 A. All state agencies, municipal corporations or other governmental agencies shall be subject to the provisions of this article and regulations adopted thereunder concerning the application of pesticides. 194 195 These agencies shall be exempt from any certification fees prescribed by this article.

B. Individuals, employees or representatives certified pursuant to this section shall be certified as 196 commercial applicators or registered technicians for the use of pesticides covered by the applicant's 197 198 certification. The certification of such individual shall be valid only when applying or supervising 199 application of pesticides used by such governmental agencies.

200 C. The provisions of this article, except those contained in subsection A of § 3.1-249.56, shall not 201 apply to (i) persons conducting laboratory research involving restricted - use pesticides; (ii) doctors of 202 medicine or doctors of veterinary medicine applying pesticides as drugs or medication, or to control pests in corpses during the normal course of their practice; (iii) providers of janitorial, cleaning, or 203 204 sanitizing services if the providers use no pesticides other than nonrestricted use sanitizers, disinfectants, and germicides; and (iv) persons who apply paints containing pesticides, provided that the pesticides in 205 206 the paints contain nonrestricted use are not restricted use pesticides; (v) classes of persons, specified by regulations of the Board, who, by virtue of their experience and knowledge regarding the safe use of 207 208 pesticides, can use or supervise the use of pesticides with minimal risk to the public health and safety; 209 and (vi) classes of persons, specified by regulations of the Board, whose use or supervision of the use of 210 pesticides, by virtue of the nature of the pesticides used or method of application of the pesticides, can 211 be accomplished with minimal risk to the public health and safety.

212 D. A painter who applies restricted-use marine antifoulent paint only under the direct, on-site 213 supervision of a commercial applicator, is not required to be a commercial applicator or a registered 214 technician. For the purposes of this subsection, one commercial applicator shall provide on-site 215 supervision for no more than eight paint applicators.

216 E. Neither the provisions of subsection A of § 3.1-249.52 nor regulations adopted thereunder shall require the certification of any person as a commercial applicator who, as part of his job duties on property owned or leased by his employer, uses or supervises the use of any pesticide that is not a 217 218 219 restricted use pesticide. This exemption does not apply to (i) any person who uses or supervises the use 220 of any pesticide on any area open to the general public at the following types of establishments: 221 educational institutions, health care facilities, day-care facilities, and convalescent facilities; (ii) any 222 person who uses or supervises the use of any pesticide within any area where open food is stored, 223 processed or sold at any establishment; (iii) any person who uses or supervises the use of any pesticide 224 on any recreational land over five acres in size; and (iv) any person otherwise specifically required by 225 this article to be certified as a commercial applicator. 226

§ 9-6.14:4.1. Exemptions and exclusions.

227 A. Although required to comply with § 9-6.18 of the Virginia Register Act (§ 9-6.15 et seq.), the 228 following agencies are exempted from the provisions of this chapter, except to the extent that they are 229 specifically made subject to §§ 9-6.14:14.1, 9-6.14:21 and 9-6.14:22: 230

1. The General Assembly.

231 2. Courts, any agency of the Supreme Court, and any agency which by the Constitution is expressly 232 granted any of the powers of a court of record.

233 3. The Department of Game and Inland Fisheries in promulgating regulations regarding the 234 management of wildlife. 235

4. The Virginia Housing Development Authority.

236 5. Municipal corporations, counties, and all local, regional or multijurisdictional authorities created 237 under this Code, including those with federal authorities, except for those created under Chapter 27 238 (§ 15.1-1228 et seq.) of Title 15.1.

239 6. Educational institutions operated by the Commonwealth provided that, with respect to § 9-6.14:22, 240 such educational institutions shall be exempt from the publication requirements only with respect to regulations which pertain to (i) their academic affairs; (ii) the selection, tenure, promotion and 241 242 disciplining of faculty and employees; (iii) the selection of students; and (iv) rules of conduct and 243 disciplining of students.

7. The Milk Commission in promulgating regulations regarding (i) producers' license and base, (ii)

- classification and allocation of milk, computation of sales and shrinkage, and (iii) class prices forproducers' milk, time and method of payment, butterfat testing and differential.
- **247** 8. The Virginia Resources Authority.
- **248** 9. Agencies expressly exempted by any other provision of this Code.
- 10. The Virginia Voluntary Formulary Board in formulating recommendations regarding amendmentsto the Formulary pursuant to § 32.1-81.

- 7. The selection, tenure, dismissal, direction or control of any officer or employee of an agency ofthe Commonwealth.
 - 8. The conduct of elections or eligibility to vote.
 - 9. Inmates of prisons or other such facilities or parolees therefrom.
- 10. The custody of persons in, or sought to be placed in, mental, penal or other state institutions aswell as the treatment, supervision, or discharge of such persons.
- **288** 11. Traffic signs, markers or control devices.
 - 12. Instructions for application or renewal of a license, certificate, or registration required by law.
- **290** 13. Content of, or rules for the conduct of, any examination required by law.
- 291 14. The administration of a pool or pools authorized by Article 7.1 (§ 2.1-234.9:1 et seq.) of Chapter
 292 14 of Title 2.1.
- 293 15. Any rules for the conduct of specific lottery games, so long as such rules are not inconsistent294 with duly adopted regulations of the State Lottery Board, and provided that such regulations are295 published and posted.
- 296 16. Orders condemning or closing any shellfish, finfish, or crustacea growing area and the shellfish,297 finfish or crustacea located thereon pursuant to Article 2 (§ 28.2-803 et seq.) of Chapter 8, Title 28.2.
- 298 C. The following agency actions otherwise subject to this chapter and § 9-6.18 of the Virginia
 299 Register Act are excluded from the operation of Article 2 (§ 9-6.14:7.1 et seq.) of this chapter:
- **300** 1. Agency orders or regulations fixing rates or prices.
- 301 2. Regulations which establish or prescribe agency organization, internal practice or procedures,302 including delegations of authority.
- 303 3. Regulations which consist only of changes in style or form or corrections of technical errors. Each
 304 promulgating agency shall review all references to sections of the Code of Virginia within their
 305 regulations each time a new supplement or replacement volume to the Code of Virginia is published to

306 ensure the accuracy of each section or section subdivision identification listed.

307 4. Regulations which:

308 (a) Are necessary to conform to changes in Virginia statutory law or the appropriation act where no 309 agency discretion is involved;

310 (b) Are required by order of any state or federal court of competent jurisdiction where no agency 311 discretion is involved; or

312 (c) Are necessary to meet the requirements of federal law or regulations, provided such regulations 313 do not differ materially from those required by federal law or regulation, and the Registrar has so 314 determined in writing; notice of the proposed adoption of these regulations and the Registrar's above determination shall be published in the Virginia Register not less than thirty days prior to the effective 315 316 date thereof.

317 5. Regulations which an agency finds are necessitated by an emergency situation. For the purposes of 318 this subdivision, "emergency situation" means (i) a situation involving an imminent threat to public health or safety or (ii) a situation in which Virginia statutory law or the appropriation act or federal law 319 or federal regulation requires that a regulation shall be effective in 280 days or less from enactment of 320 321 the law or the appropriation act or the effective date of the federal regulation, and the regulation is not 322 exempt under the provisions of subdivision C 4 of this section. In such cases, the agency shall state in 323 writing the nature of the emergency and of the necessity for such action and may adopt such regulations 324 with the prior approval of the Governor. Such regulations shall be limited to no more than twelve 325 months in duration. During the twelve-month period, an agency may issue additional emergency regulations as needed addressing the subject matter of the initial emergency regulation, but any such 326 327 additional emergency regulations shall not be effective beyond the twelve-month period from the effective date of the initial emergency regulation. If the agency wishes to continue regulating the subject 328 329 matter governed by the emergency regulation beyond the twelve-month limitation, a regulation to replace 330 the emergency regulation shall be promulgated in accordance with Article 2 (§ 9-6.14:7.1 et seq.) of this chapter. The Notice of Intended Regulatory Action to promulgate a replacement regulation shall be 331 published within sixty days of the effective date of the emergency regulation, and the proposed 332 333 replacement regulation shall be published within 180 days after the effective date of the emergency 334 regulation.

336 7. Preliminary program permit fees of the Department of Environmental Quality assessed pursuant to 337 subsection C of § 10.1-1322.2.

338 8. Regulations of the Pesticide Control Board adopted pursuant to subsection B of § 3.1-249.51 or 339 item (v) or (vi) of subsection C of \S 3.1-249.53.

340 Whenever regulations are adopted under this subsection C, the agency shall state as part thereof that 341 it will receive, consider and respond to petitions by any interested person at any time with respect to 342 reconsideration or revision. The effective date of regulations adopted under this subsection shall be in accordance with the provisions of § 9-6.14:9.3, except in the case of emergency regulations, which shall 343 344 become effective as provided in § 9-6.14:9 A.

345 D. The following agency actions otherwise subject to this chapter are excluded from the operation of 346 Article 3 (§ 9-6.14:11 et seq.) of this chapter: 347

- 1. The assessment of taxes or penalties under the tax laws.
- 348 2. The award or denial of claims for workers' compensation.
- 349 3. The grant or denial of public assistance.
- 350 4. Temporary injunctive or summary orders authorized by law.
- 351 5. The determination of claims for unemployment compensation or special unemployment.
- 352 6. The award or denial of individual student loans by the Virginia Education Loan Authority.

353 7. The determination of applications for guaranty of individual student loans or the determination of 354 default claims by the State Education Assistance Authority.

355 E. The Marine Resources Commission, otherwise subject to this chapter and § 9-6.18 of the Virginia 356 Register Act, is excluded from the operation of subsection C of this section and of Article 2 (§ 9-6.14:7.1 et seq.) of this chapter; however, the authorization for any general permit or guidelines for 357 358 activity undertaken pursuant to Title 62.1 by the Marine Resources Commission shall be in accordance 359 with the provisions of this chapter.

360 F. A regulation for which an exemption is claimed under this section and which is placed before a 361 board or commission for consideration shall be provided at least two days in advance of the board or 362 commission meeting to members of the public that request a copy of that regulation. A copy of that regulation shall be made available to the public attending such meeting. 363

G. The Joint Legislative Audit and Review Commission shall conduct a review periodically of 364 exemptions and exclusions authorized by this section. The purpose of this review shall be to assess 365 whether there are any exemptions or exclusions which should be discontinued or modified. 366

H. Minor changes to regulations being published in the Virginia Administrative Code under the 367

368 Virginia Register Act, Chapter 1.2 (§ 9-6.15 et seq.) of this title, made by the Virginia Code **369** Commission pursuant to § 9-77.10:1 shall be exempt from the provisions of this chapter.
