## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend the Code of Virginia by adding sections numbered 32.1-127.1:02 and 54.1-2403.3, 3 relating to medical records.

# Be it enacted by the General Assembly of Virginia:

#### 7 1. That the Code of Virginia is amended by adding sections numbered 32.1-127.1:02 and 8 54.1-2403.3 as follows: 9

§ 32.1-127.1:02. Medical records; ownership; provision of copies.

10 A. As used in this section, "health care provider" shall have the same meaning as set forth in § 8.01-581.1, and "medical record" shall have the same meaning as set forth in § 42.1-77. 11

12 B. Medical records are the property of the health care provider maintaining them and shall be removed from the premises where they are maintained without approval of the owner only in 13 14 accordance with court order or subpoend consistent with § 8.01-413, or in accordance with other 15 provisions of state or federal law.

16 C. Health care providers shall keep medical records confidential and only authorized personnel shall 17 have access to such records. Health care providers shall release copies of a patient's medical record 18 only (i) to any person with the written consent of the patient; the patient's legal representative; a minor 19 patient's parent, guardian, or legal representative; or other person authorized to consent to treatment of 20 minors pursuant to § 54.1-2969; (ii) to duly authorized state or federal health authorities or others as specifically authorized by the provisions of this Code or of federal law; or (iii) in connection with the 21 22 work of any entity established as set forth in § 8.01-581.16 to evaluate the adequacy or quality of 23 professional services or the competency and qualifications for professional staff privileges. Records 24 relating to a deceased patient or a patient determined by his attending physician to be incapable of making an informed decision, as that condition is defined in § 54.1-2982, shall be provided to any of the 25 following persons, in order of priority stated, upon the written request of such person, unless the health 26 27 care provider maintaining the records is aware of any available person in a higher class: (i) the 28 personal representative of a deceased patient; (ii) a legal guardian or committee of the patient; (iii) the 29 patient's legal spouse; (iv) an adult child of the patient; (v) either parent of the patient; (vi) an adult 30 brother or sister of the patient; or (vii) any other relative of the patient in the descending order of 31 blood relationship. Copies of medical records requested for purposes of litigation shall be requested and 32 provided in accordance with the provisions of § 8.01-413.

33 D. Requests for copies of medical records shall (i) be in writing, dated, and signed by the requester; 34 (ii) identify the nature of the information requested; and (iii) include evidence of the authority of the 35 requester to receive such copies and identification of the person to whom the information is to be disclosed. Within fifteen days of receipt of a request for copies of medical records, the health care 36 37 provider shall do one of the following: (i) furnish such copies to any requester authorized to receive 38 them; (ii) inform the requester if the information does not exist or cannot be found; (iii) if the health 39 care provider does not maintain a record of the information, so inform the requester and provide the 40 name and address, if known, of the health care provider who maintains the record; or (iv) deny the 41 request (a) under subsection E of this section, (b) on the grounds that the requester has not established 42 his authority to receive such records or proof of his identity, or (c) as otherwise provided by law. 43 Procedures set forth in this section shall apply only to requests for medical records not specifically 44 governed by other provisions of this Code or of federal law.

45 E. Copies of a patient's medical records shall not be furnished to such patient or anyone authorized to act on the patient's behalf where the patient's attending physician or the patient's clinical psychologist 46 47 has made a part of the patient's record a written statement that, in his opinion, the furnishing to or review by the patient of such records would be injurious to the patient's health or well-being. If any 48 49 custodian of medical records denies a request for copies of records based on such statement, the 50 custodian shall permit examination and copying of the medical record by another such physician or 51 clinical psychologist selected by the patient, whose licensure, training and experience relative to the patient's condition is at least equivalent to that of the physician or clinical psychologist upon whose 52 53 opinion the denial is based. The person or entity denying the request shall inform the patient of the 54 patient's right to select another reviewing physician or clinical psychologist under this subsection who 55 shall make a judgment as to whether to make the record available to the patient. Any record copied for 56 review by the physician or clinical psychologist selected by the patient shall be accompanied by a

- determined that the patient's review of his record would be injurious to the patient's health or 58

- Medical records maintained by any health care provider as defined in § 8.01-581.1 shall be the 61

- property of such health care provider. Such health care provider shall release copies of any such medical records in compliance with § 32.1-127.1:02 or § 8.01-413, if the request is made for purposes 63
- of litigation, or as otherwise provided by state or federal law. 64
