## **HOUSE BILL NO. 2213**

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on General Laws

on January 30, 1995)

(Patron Prior to Substitute—Delegate Wardrup)

- 34 56 7 A BILL to amend and reenact §§ 63.1-68 and 63.1-68.1 of the Code of Virginia and to repeal the fifth enactment of Chapter 755 of the Acts of Assembly of 1992 as amended by Chapter 666 of the Acts of Assembly of 1994, relating to the Board and Department for the Visually Handicapped. 8
- 9 Be it enacted by the General Assembly of Virginia:
- 1. That §§ 63.1-68 and 63.1-68.1 of the Code of Virginia are amended and reenacted as follows: 10

11 § 63.1-68. Appointment, terms and qualifications of members of Board; eligibility for reappointment; 12 auorum.

Prior to July 1, 1988, the Virginia Board for the Visually Handicapped, hereinafter sometimes called 13 14 the Board, shall consist of seven members who shall be appointed by the Governor for terms of seven years each, one term beginning each year. Effective July 1, 1988, the members of the Board shall be 15 appointed by the Governor for terms of four years. No person shall be eligible to serve more than two 16 successive terms, provided that a person heretofore or hereafter appointed to fill a vacancy may serve 17 two additional successive terms. Incumbency during a current term when this section becomes effective 18 shall constitute the first of two successive terms with respect to eligibility for reappointment. Vacancies 19 20 occurring on the Board shall be filled by the Governor for the unexpired term. All appointments 21 hereunder shall be made without reference to party affiliations, but solely on account of the fitness of the appointees to discharge their duties as members of the Board. The membership of the Board, 22 however, shall at all times include two four persons who are blind. Four members of the Board shall constitute a quorum for the transaction of any lawful business. Annually, the Board shall elect it 23 24 25 chairman from among its blind members.

26 Wherever in the laws of this Commonwealth reference is made to the Virginia Commission for the 27 Blind or to the Virginia Commission for the Visually Handicapped, such reference shall be deemed to 28 be to the Virginia Department for the Visually Handicapped or to the Virginia Board for the Visually 29 Handicapped, whichever is appropriate for the context.

§ 63.1-68.1. (Effective until July 1, 1995) Powers and duties of Board; form of materials.

A. The Board shall exercise the following general powers and duties:

32 1. Advise the Governor, the Secretary of Health and Human Resources, the Commissioner, and the General Assembly on the delivery of public services to and the protection of the rights of persons with 33 disabilities on matters relating to this title, and on such other matters as the Governor, Secretary, 34 35 Commissioner, or the General Assembly may request; and

36 2. Review and comment on policies, budgets and requests for appropriations for the Department prior 37 to their submission to the Secretary of Health and Human Resources and the Governor and on 38 applications for federal funds.

39 B. Material submitted by the Commissioner for review and comment by the Board, when practicable, 40 shall be in the medium or format suitable for review by each member of the Board.

2. That the fifth enactment of Chapter 755 of the Acts of Assembly of 1992, as amended by 41 Chapter 666 of the Acts of Assembly of 1994, is repealed. 42

3. That the provisions of this act shall not effect Board members currently serving terms on the 43 Board. However, upon the expiration of initial Board terms, Board members shall be appointed in 44

accordance with the provisions of this act. 45
