

VIRGINIA ACTS OF ASSEMBLY — CHAPTER

An Act to amend and reenact § 16.1-69.6:1 as it is currently effective, and § 17-119.1:2 of the Code of Virginia, relating to number of district and circuit court judges.

Be it enacted by the General Assembly of Virginia:

1. That § 16.1-69.6:1 as it is currently effective, and § 17-119.1:2 of the Code of Virginia are amended and reenacted as follows:

§ 16.1-69.6:1. Number of judges.

For the several judicial districts there shall be full-time general district court judges and juvenile and domestic relations district court judges, the number as hereinafter set forth, who shall during their service reside within their respective districts, except as provided in § 16.1-69.16, and whose compensation and powers shall be the same as now and hereafter prescribed for general district court judges and juvenile and domestic relations district court judges.

60 A. For the several judicial circuits there shall be judges, the number as hereinafter set forth, who
61 shall during their service reside within their respective circuits and whose compensation and powers
62 shall be the same as now and hereafter prescribed for circuit judges. The judges in office when this shall
63 take effect shall continue in office for the term for which elected or appointed.

96 B. On and after January 1, 1975, no additional circuit court judge shall be authorized or provided for
97 any judicial circuit until the Judicial Council has made a study of the need for such additional circuit
98 court judge and has reported its findings and recommendations to the Courts of Justice Committees of
99 the House of Delegates and Senate. In its study, the Judicial Council shall consider, and report its
100 findings regarding, the reduced case load that will occur if Family Court judgeships are authorized in
101 accordance with the provisions of Chapter 4.1, Article 2 (§ 16.1-69.6:1 et seq.) of Title 16.1. Nor shall
102 the boundary of any judicial circuit be changed until a study has been made by the Judicial Council and
103 a report of its findings and recommendations made to said Committees.

104 C. If the Judicial Council finds the need for an additional circuit court judge after a study is made
105 pursuant to subsection B, the study shall be made available to the State Compensation Board and the
106 Courts of Justice Committees of the House of Delegates and Senate. The State Compensation Board
107 shall make a study of the need to provide additional courtroom security and deputy court clerk staffing.
108 This study shall be reported to the Courts of Justice Committees of the House of Delegates and the
109 Senate, and to the Department of Planning and Budget.

110 **2. That the provisions of this act set forth in § 16.1-69.6:1 shall expire on July 1, 1996, if funds are**
111 **provided pursuant to the provisions of the third enactment of Chapter 930 of the 1993 Acts of**
112 **Assembly as amended by the second enactment of Chapter 564 of the 1994 Acts of Assembly.**
