- § 10.1-1187.1. Citizens' Advisory Board established; eligibility; meetings; compensation.
 - A. There is hereby established the Citizens' Advisory Board (the Board) which shall advise the Director of the Department. The Board shall consist of eleven citizen members, who represent the interests of private citizens, appointed as follows: four members to be appointed by the Senate Committee on Privileges and Elections and seven members to be appointed by the Speaker of the House of Delegates.
- 318 B. No person shall be eligible for membership on the Board if he earns more than two percent of his income from an entity regulated by the Department.
- C. No member of the Board shall receive any salary or benefits from an entity regulated by the Department.
- D. The Board shall meet at least quarterly. Members of the Board shall receive no remuneration for their service, but shall be reimbursed for their reasonable and necessary travel expenses.
- E. The Board shall make recommendations on policies and programs of the Department to the Director.
