11	Be it enacted by the General Assembly of Virginia:
12	1. That §§ 28.2-701, 28.2-702, 28.2-704, and 28.2-708 of the Code of Virginia are amended and
13	reenacted and that the Code of Virginia is amended by adding sections numbered 28.2-708.1 and
14	28.2-712.1 as follows:
15	§ 28.2-701. Crab traps and crab pounds; regulations; penalty.
16	A. The Commission shall promulgate regulations governing the use, placement, and maintenance of
17	crab traps and crab pounds. Such regulations shall include, but not be limited to, a requirement that
18	every owner or user of a crab trap or crab pound completely remove traps, leads, wires, poles and all
19	other related gear from the water not later than October 31 of each year.
20	B. Any person convicted of violating any provision of a regulation promulgated under this section is
21	guilty of a Class 3 misdemeanor.
22	§ 28.2-702. Licenses to take crabs; shedding operations; amount of fee.
23 24	Any person desiring to take or catch crabs for market or profit from the waters of this Commonwealth, or waters under its jurisdiction, or any person desiring to engage in the business of
25	buying or marketing crabs for packing or canning crabs, shall pay to any officer the following fees:
23 26	1. For each person taking or catching crabs by dip nets, \$8;
2 7	2. For ordinary trotlines, \$8;
28	3. For patent trotlines, \$31;
29	4. For up to 100 crab pots, \$29;
30	5. For over 100 but not more than 300 crab pots, \$48;
31	6. For over 300 but not more than 500 crab pots, \$100;
32	7. For over 500 crab pots, \$250;
33	8. For each boat used for taking or catching hard crabs with dredges, \$58;
34	9. For each crab trap or crab pound, \$5;
35	10. For each single-rigged crab-scrape boat, \$16;
36 37	11. For each double-rigged crab-scrape boat, \$32; 12. For up to 20 tanks and floats for shedding crabs, \$7.50;
37 38	13. For more than 20 tanks or floats for shedding crabs, \$1.50,
39	14. For taking or catching peeler crabs using peeler pots, \$29.
40	§ 28.2-704. Sale of crabbing licenses.
41	The Commission may require the purchase of licenses before each crab season begins. It may set
42	time periods for the sale of licenses for taking crabs in order to determine the appropriateness of
43	instituting seasonal conservation measures and may grant extensions to individual applicants when it
44	finds exceptional circumstances exist.
45	The number of hard crab and peeler pot licenses shall be limited to the number of licenses existing
46	for each of these gear types on November 27, 1995. Only those individuals who held a 1995 hard crab
47	pot or peeler pot license on or before November 27, 1995, shall be eligible to participate in the 1996
48 49	hard crab pot and peeler pot fisheries and shall be restricted to the same licensing category as defined in § 28.2-702 as he participated in 1995 on or before November 27, 1995. Those individuals who held a
49 50	1995 license on or before November 27, 1995, for more than 300 hard crab pots or 300 peeler pots
50 51	shall be limited to 300 pots in each such fishery for which they held a license.
51 52	§ 28.2-708. Limitations on sizes of crabs to be taken; inspection of catch; exemption; penalty.
53	A. It is unlawful for any person to catch, take or have in his possession more than ten hard crabs per
54	United States standard bushel or thirty-five hard crabs per barrel, which measure less than five inches
55	across the shell from tip to tip of the longest spikes, or to destroy them in any manner. It is unlawful
56	for any person to catch, take or have in his possession more than ten softshell crabs per United States
57	standard bushel or thirty-five softshell crabs per barrel, which measure less than three and one-half
58	inches across the shell from tip to tip of the longest spikes, or to destroy them in any manner. Those
59	undersized crabs in excess of the allowance level levels shall be immediately returned to the water alive.

Adult female crabs, and peeler crabs and soft crabs are exempt from these limitations. 60

B. Any officer may grade or cull any number of barrels, baskets or containers of crabs in any 61 62 person's possession.

63 If the officer finds more than ten undersize hard crabs or softshell crabs per United States standard 64 bushel or thirty-five per barrel, he shall seize the entire quantity of crabs in or from each such container, 65 and the person who possessed the crabs shall immediately return them to the water. Refusal to return the 66 crabs to the water is a separate offense from any other violation.

C. Crabs which have been purchased by and are in the possession of a buyer and crabs which have 67 68 been transported at least five miles from the nearest salt water are exempt from this requirement.

D. The Commission may change such size restrictions for a period not to exceed sixty days to 69 70 respond to significant ecological changes.

71 E. A violation of this section is a Class 3 misdemeanor. 72

§ 28.2-708.1. Limitations on the taking of sponge crabs; inspection; penalty.

A. It is unlawful for any person to possess a female crab with an egg mass of brown to black 73 coloration. Those female crabs caught or taken with brown to black egg masses shall be immediately 74 returned to the water alive. If any female crab with an egg mass of brown to black coloration is found 75 in a culled container of crabs, the entire quantity of crabs in or from the container shall be seized by 76 77 the officer finding the violation.

78 B. Any officer may grade, cull or inspect any number of barrels, baskets or containers of crabs in 79 any person's possession.

80 C. A violation of this section is a Class 3 misdemeanor.

81 § 28.2-712.1. Buoy marking system.

The Commission shall establish a buoy marking system for tracking the number of hard crab pots 82 83 and peeler pots being fished by those required by this subtitle to have a license for such gear. Buoy 84 markers shall be issued by the Commissioner. Once the marking system has been established, each 85 licensee shall display and maintain the buoy markers in a legible and visible manner on the float or

86 stake attached to each crab pot.

87 Noncompliance with the buoy marking system is a Class 1 misdemeanor.
