VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact the second enactments of Chapters 749 and 823 of the 1995 Acts of 3 Assembly, relating to the Chesapeake Bay Restoration Fund.

6 Be it enacted by the General Assembly of Virginia:

7 1. That the second enactment of Chapter 749 of the 1995 Acts of Assembly is amended and 8 reenacted as follows: 9

2. § 1. Advisory committee established; membership; duties.

10 A. There is hereby established within the legislative branch the Chesapeake Bay Restoration Fund Advisory Committee to be known as "the Committee." The Committee shall advise the General 11 12 Assembly on the expenditure of moneys received in the Chesapeake Bay Restoration Fund (the Fund).

13 B. The Committee shall consist of seven persons as follows: two members of the House of Delegates and two persons appointed by the Speaker of the House of Delegates, one of whom shall be a 14 15 representative of the Chesapeake Bay Foundation; one member of the Senate and two persons appointed by the Senate Committee on Privileges and Elections, one of whom shall be a representative of the 16 Virginia Association of Soil and Water Conservation Districts. All persons appointed to the Committee 17 18 shall be representative of the interests associated with the restoration and conservation of the Chesapeake 19 Bay. At least one citizen member shall be a current holder of the "Friend of the Chesapeake" license plate. Members of the Committee shall serve for terms of four years. Legislators' terms shall be 20 21 concurrent with their elected terms of office. Appointments to fill vacancies shall be for the unexpired term and shall be made in the same manner as the original appointment. Members shall not be eligible 22 23 to serve more than two consecutive terms. The Committee shall elect a chairman and vice-chairman 24 from among its legislative membership. Members shall receive no compensation for their services, but 25 shall be reimbursed out of the Fund for their necessary and actual expenses incurred in connection with 26 their duties as Committee members. The Division of Legislative Services shall be reimbursed from the 27 Fund for costs, as shall be approved by the Committee, incurred in providing administrative assistance to the Committee. The Committee shall meet at least one time each year, and additional meetings may 28 29 be held at the call of the chairman.

30 C. The Committee shall develop goals and guidelines for the use of the Fund, which may include but 31 not be limited to cooperative programs with, or project grants to, state agencies, the federal government, 32 or any not-for-profit agency, institution, organization, or entity, public or private, whose purpose is to 33 provide environmental education and projects relating to the restoration and conservation of the 34 Chesapeake Bay. Moneys in the Fund may not be used to supplant existing general fund appropriations 35 except as provided in subsection B.

D. No later than December 1 of each year, the Committee shall present to the Governor and the 36 37 General Assembly a plan for expenditure of any amounts in the Fund.

38 E. Staffing of the Committee shall be provided by the Division of Legislative Services.

39 2. That the second enactment of Chapter 823 of the 1995 Acts of Assembly is amended and 40 reenacted as follows: 41

2. § 1. Advisory committee established; membership; duties.

42 A. There is hereby established within the legislative branch the Chesapeake Bay Restoration Fund Advisory Committee to be known as "the Committee." The Committee shall advise the General 43 Assembly on the expenditure of moneys received in the Chesapeake Bay Restoration Fund (the Fund). 44

45 B. The Committee shall consist of seven persons as follows: two members of the House of Delegates and two persons appointed by the Speaker of the House of Delegates, one of whom shall be a 46 representative of the Chesapeake Bay Foundation; one member of the Senate and two persons appointed 47 by the Senate Committee on Privileges and Elections, one of whom shall be a representative of the 48 Virginia Association of Soil and Water Conservation Districts. All persons appointed to the Committee 49 shall be representative of the interests associated with the restoration and conservation of the Chesapeake 50 Bay. At least one citizen member shall be a current holder of the "Friend of the Chesapeake" license 51 52 plate. Members of the Committee shall serve for terms of four years. Legislators' terms shall be 53 concurrent with their elected terms of office. Appointments to fill vacancies shall be for the unexpired 54 term and shall be made in the same manner as the original appointment. Members shall not be eligible 55 to serve more than two consecutive terms. The Committee shall elect a chairman and vice-chairman 56 from among its legislative membership. shall be reimbursed out of the Fund for their necessary and actual expenses incurred in connection with
their duties as Committee members. *The Division of Legislative Services shall be reimbursed from the Fund for costs, as shall be approved by the Committee, incurred in providing administrative assistance*to the Committee. The Committee shall meet at least one time each year, and additional meetings may
be held at the call of the chairman.
C. The Committee shall develop goals and guidelines for the use of the Fund, which may include but
not be limited to cooperative programs with or project grants to state agencies the federal government

not be limited to cooperative programs with, or project grants to, state agencies, the federal government,
or any not-for-profit agency, institution, organization, or entity, public or private, whose purpose is to
provide environmental education and projects relating to the restoration and conservation of the
Chesapeake Bay. Moneys in the Fund may not be used to supplant existing general fund appropriations
except as provided in subsection B.

68 D. No later than December 1 of each year, the Committee shall present to the Governor and the69 General Assembly a plan for expenditure of any amounts in the Fund.

70 E. Staffing of the Committee shall be provided by the Division of Legislative Services.
