971869196 **HOUSE JOINT RESOLUTION NO. 554** 1 AMENDMENT IN THE NATURE OF A SUBSTITUTE 234567 (Proposed by the Senate Committee on Rules on February 17, 1997) (Patron Prior to Substitute—Delegate Darner) Directing the Virginia Housing Study Commission, with representation from the Virginia Water Project, Inc., the Southeast Rural Communities Assistance Project, the Virginia Municipal League and the 8 Virginia Association of Counties, and in conjunction with the Commonwealth's public and private 9 water and water treatment providers, to study an indoor plumbing assistance program through 10 voluntary invoice contributions to assist low-income households. 11 WHEREAS, during the past decade various public, private, and nonprofit organizations in the Commonwealth have sponsored a variety of programs designed to assist households living with 12 inadequate residential water and wastewater facilities; and 13 14 WHEREAS, despite the success of these programs, thousands of lower income Virginians continue to 15 live in housing lacking the most basic water and wastewater facilities; and 16 WHEREAS, it is reported that at least 53,000 housing units in Virginia are without any indoor plumbing facilities, and over 90,000 housing units in Virginia are utilizing sewage disposal means — 17 generally outdoor privies — other than septic tank or public sewer systems; and 18 WHEREAS, as governmental sources of funding for housing improvement programs become more 19 20 limited, there is an increased need to find alternative means of financing indoor plumbing efforts; and 21 WHEREAS, one option for encouraging voluntary private sector assistance is the establishment of a special fund to which Virginia residents could contribute through their water and sewer utility invoices 22 23 - a program similar to the one established by Virginia Power to provide assistance to low-income 24 household for energy and heating costs; now, therefore, be it 25 RESOLVED by the House of Delegates, the Senate concurring, That the Virginia Housing Study Commission, with representation from the Virginia Water Project, Inc., the Southeast Rural Communities 26 27 Assistance Project, the Virginia Municipal League and the Virginia Association of Counties, and in 28 conjunction with the Commonwealth's public and private water and water treatment providers, study an 29 indoor plumbing assistance program through voluntary invoice contributions to assist low-income 30 households. The Virginia Housing Study Commission shall complete its work in time to submit its findings and 31 32

recommendations to the Governor and the 1998 Session of the General Assembly as provided in the
procedures of the Division of Legislative Automated Systems for the processing of legislative
documents.

RESOLVED FURTHER, That the Clerk of the House of Delegates shall transmit copies of this
resolution to the directors of the Virginia Water Project, Inc., the Southeast Rural Communities
Assistance Project, the Virginia Municipal League and the Virginia Association of Counties to apprise
them of the sense of the General Assembly in this matter.
