A BILL to amend and reenact §§ 2.1-1.5, 2.1-1.9, 2.1-20.4, 2.1-51.27, 9-6.23, and 9-6.25:3 of the Code of Virginia and to amend the Code of Virginia by adding in Title 9 a chapter numbered 49, consisting of sections numbered 9-371, 9-372, and 9-373, relating to the Commission on Virginia's Public Historical Records Collection.

Be it enacted by the General Assembly of Virginia:

1. That §§ 2.1-1.5, 2.1-1.9, 2.1-20.4, 2.1-51.27, 9-6.23, and 9-6.25:3 are amended and reenacted and that of the Code of Virginia is amended by adding in Title 9 a chapter numbered 49, consisting of sections numbered 9-371, 9-372, and 9-373, as follows:

§ 2.1-1.5. Entities not subject to standard nomenclature.

240 B. Individual members of boards, commissions, committees, councils, and other similar bodies
241 appointed at the state level and receiving compensation for their services on January 1, 1980, but who
242 will not receive compensation under the provisions of this article, shall continue to receive compensation
243 at the January 1, 1980, rate until such member's current term expires.
244 § 2.1-51.27. Agencies for which responsible.

The Secretary of Administration shall be responsible to the Governor for the following agencies and boards: Department of Information Technology, Council on Information Management, Department of Personnel and Training, Department of General Services, Compensation Board, Secretary of the Commonwealth, Department of Employee Relations Counselors, Department of Veterans' Affairs, Virginia Veterans Care Center Board of Trustees, Commission on Local Government, *Commission on Virginia's Public Historical Records Collection*, Charitable Gaming Commission, and Virginia Public Broadcasting Board. The Governor may, by executive order, assign any other state executive agency to the Secretary of Administration, or reassign any agency listed above to another secretary.

§ 9-6.23. (Effective July 1, 1998) Prohibition against service by legislators on boards, commissions, and councils within the executive branch.

Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils within the executive branch which are responsible for administering programs established by the General Assembly. Such prohibition shall not extend to boards, commissions, and councils engaged solely in policy studies or commemorative activities. If any law directs the appointment of any member of the General Assembly to a board, commission, or council in the executive branch which is responsible for administering programs established by the General Assembly, such portion of such law shall be void, and the Governor shall appoint another person from the Commonwealth at large to fill such a position. The provisions of this section shall not apply, however, to members of the Board for Branch Pilots, who shall be appointed as provided for in § 54.1-901; to members of the Board on Veterans' Affairs, who shall be appointed as provided for in § 2.1-741; to members of the Council on Indians, who shall be appointed as provided for in § 9-138.1; to members of the Virginia Technology Council, who shall be appointed as provided for in § 9-145.51; to members of the Board of Trustees of the Southwest Virginia Higher Education Center, who shall be appointed as provided for in § 23-231.3; to members of the Maternal and Child Health Council, who shall be appointed as provided for in § 9-318; to members of the Virginia Interagency Coordinating Council who shall be appointed as provided for in § 2.1-750; to members of the Advisory Council on the Virginia Business-Education Partnership Program, who shall be appointed as provided in § 9-326; to members of the Advisory Commission on Welfare Reform, who shall be appointed as provided for in § 63.1-133.44; to members of the Virginia Correctional Enterprises Advisory Board, who shall be appointed as provided for in § 2.1-451.2; to members appointed to the Virginia Veterans Cemetery Board pursuant to § 2.1-739.2; to members appointed to the Board of Trustees of the Roanoke Higher Education Authority pursuant to § 23-231.15; to members of the Commonwealth Competition Commission, who shall be appointed as provided for in § 9-343; to members of the Virginia Geographic Information Network Advisory Board, who shall be appointed as provided for in § 2.1-563.41; ~~or~~ to members of the Advisory Commission on the Virginia Schools for the Deaf and the Blind, who shall be appointed as provided for in § 22.1-346.1; *or to members of the Commission on Virginia's Public Historical Records Collection, who shall be appointed as provided for in § 9-372.*

339 CHAPTER 49.

340 COMMISSION ON VIRGINIA'S PUBLIC HISTORICAL RECORDS COLLECTION.

341 § 9-371. *Commission created; purpose.*

342 *There is hereby created the Commission on Virginia's Public Historical Records Collection,*
 343 *hereinafter referred to as the Commission. The purpose of the Commission shall be to provide direction*
 344 *and oversight to state agencies with significant historical records collection holdings. The Commission*
 345 *shall evaluate each agency's particular collection and make recommendations to the agency and the*
 346 *General Assembly regarding program needs including cataloguing, preservation, acquisition and*
 347 *accessibility. In performing its duties, the Commission shall encourage the development of uniform*
 348 *policies and services to ensure that the holdings of the Commonwealth are appropriately preserved and*
 349 *accessible.*

350 § 9-372. *Membership; appointment; terms.*

351 *A. The Commission shall consist of nineteen members. The appointment of members shall be as*
 352 *follows: seven members from the House of Delegates to be appointed by the Speaker of the House; four*
 353 *members from the Senate of Virginia to be appointed by the Senate Committee on Privileges and*
 354 *Elections; and seven citizens to be appointed by the Governor. Of the citizens appointed by the*
 355 *Governor, two shall be representatives from the Swem and Alderman libraries, two shall be*
 356 *representatives of historical societies, two shall be representatives of genealogical societies and one*
 357 *shall be a representative of a clerk of the court office. The State Archivist, as appointed pursuant to*
 358 *§ 42.1-79, shall serve as an ex officio member of the Commission with full voting privileges.*

359 *B. The terms of legislative members shall be coincident with their service in the house from which*
 360 *appointed. The appointees of the Governor shall serve for terms of four years. Their successors shall be*
 361 *appointed for like terms, and vacancies occurring other than by expiration of term shall be filled for the*
 362 *unexpired term and shall be made in the same manner as the original appointment. All members of the*
 363 *Commission shall be compensated as specified in § 14.1-18, and shall be reimbursed for expenses*
 364 *incurred in the performance of their duties.*

365 § 9-373. *Powers and duties of the Commission.*

366 *A. The Commission shall have the power and duty to:*

367 *1. Determine the size and scope of historical records among agencies of the Commonwealth;*

- 368 2. Supervise the cataloguing of historical records by state agencies and recommend preservation
369 priorities;
- 370 3. Recommend to the Governor and General Assembly policies, legislation and funding to further the
371 Commonwealth's collection and preservation of historical records collections;
- 372 4. Promote public-private collaboration for archival preservation and collection;
- 373 5. Develop interagency mechanisms for the planning and coordination of preservation efforts;
- 374 6. Review and coordinate all agency funding requests with emphasis on funding for preservation and
375 accessibility;
- 376 7. Provide planning and technical assistance for agencies lacking appropriate preservation and
377 acquisition plans;
- 378 8. Promote and encourage the development of programs and curricula within the Commonwealth's
379 institutions of higher education for the training of personnel involved with historical records collections;
380 and
- 381 9. Monitor the progress of each agency's work with their historical records collections with special
382 attention to preservation and accessibility.
- 383 B. The Commission shall report annually to the Governor and at such other times as required by the
384 Governor or the General Assembly.
