## HOUSE BILL NO. 556

*A BILL to amend and reenact §§ 2.1-1.7 and 9-6.25:2 of the Code of Virginia and to repeal Chapter 22.6 (§§ 9-145.21 through 9-145.29) of Title 9 of the Code of Virginia, relating to the Southside Virginia Marketing Council.*

### **Be it enacted by the General Assembly of Virginia:**

#### **1. That §§ 2.1-1.7 and 9-6.25:2 of the Code of Virginia are amended and reenacted as follows:**

§ 2.1-1.7. State councils.
