182 "Board" means the Board of Agriculture and Consumer Services.

183 "Business firm" means any corporation, partnership, electing small business (Subchapter S) corporation, limited liability company, or sole proprietorship authorized to do business in this Commonwealth subject to tax imposed by Articles 2 (§ 58.1-320 et seq.) and 10 (§ 58.1-400 et seq.) of 184 185 Chapter 3, Chapter 12 (§ 58.1-1200 et seq.), Article 1 (§ 58.1-2500 et seq.) of Chapter 25, or Article 2 186 187 (§ 58.1-2620 et seq.) of Chapter 26 of Title 58.1.

188 "Charity food provider" means a nonprofit, charitable organization which operates on a continuing 189 basis as a food pantry, soup kitchen, community kitchen, emergency shelter, or other program which 190 seeks to relieve the incidence of hunger, undernutrition, or supplemental or emergency short-term food 191 or nutritional shortages among needy individuals and families, homeless people, or victims of domestic 192 violence.

193 "Commissioner" means the Commissioner of the Virginia Department of Agriculture and Consumer 194 Services.

"Department" means the Virginia Department of Agriculture and Consumer Services.

"Food bank" means a nonprofit charitable organization that (i) is exempt from income taxation 196 197 under the provisions of §§ 501 (c) (3) and 501 (c) (4) of the Internal Revenue Code of 1986, as 198 amended from time to time, and (ii) distributes food to charity food providers.

199 § 3.1-1105. Charity Food Assistance Advisory Board.

200 A. There is hereby established within the Department the Charity Food Assistance Advisory Board, 201 which shall advise the Board and the Department on the implementation of a Virginia charity food 202 purchase program and study programs or other ways the Department or other agencies might help to 203 reduce the incidence of hunger, undernutrition, and short-term food or nutritional shortages among the 204 needy. The Advisory Board shall consist of fifteen members to be appointed by the Governor, and shall include the Commissioner of Agriculture and Consumer Services or his designee, the Director of the 205 206 Department of General Services or his designee, and one representative each of the following: a 207 statewide agriculture organization, a cooperative program operated by state-supported institutions of 208 higher education charged with providing the people of the Commonwealth with information relating to agriculture and home economics, the wholesale grocery industry, the retail grocery industry, the food 209 210 processing industry, the meat industry, the poultry industry, the dairy industry, and the bottling industry. 211 Four members shall represent food banks.

212 B. The Advisory Board shall annually elect a chairman from among its members. The chairman shall 213 fix the times and places of meetings. Members of the Advisory Board shall serve without compensation 214 but shall be reimbursed for their reasonable and necessary expenses incurred in the performance of 215 their duties as Advisory Board members.

216 C. The Advisory Board shall develop recommendations regarding a charity food donation tax credit 217 program and a charity food purchase and distribution program, and shall report such recommendations to the Commissioner no later than July 1, 1999. The Advisory Board may make such other 218 219 recommendations to the Commissioner as are adopted by a majority of its members.

220 D. The Commissioner shall report his recommendations regarding a charity food donation tax credit 221 program and a charity food purchase and distribution program to the Governor and the chairmen of the 222 House Appropriations Committee, House Finance Committee, and Senate Finance Committee no later 223 than December 1, 1999. 224
